

FREQUENTLY ASKED QUESTIONS

Where can I ride my ORV?

- ORVs are allowed, without a permit, on any ORV designated street or trail as indicated on the map. (GREEN)

How do I get to the designated streets or trails if I do not have a trailer to transport my ORV?

- A person MAY be issued a permit to ride on a street other than those designated in green on the map. That person must meet the requirements outlined in the ORV ordinance.

What are the requirements for operating an ORV within the city limits?

- A person must meet one of the following requirements:
 - Must be 18 years old and possess an ORV safety certificate OR a valid driver's license.
 - If the operator is under the age of 18, they must possess a valid driver's license, or be under direct supervision of a parent or guardian and possess an ORV safety certificate.
 - Individuals 12 years of age and under MAY NOT operate an ORV within City limits.

What if I am just visiting?

- A visitor MAY be issued a permit to travel on a non-designated street to gain access to a designated trail or street, providing that the individual meets the requirements listed above.

RULES OF OPERATION

This list DOES NOT contain all the laws pertaining to the operation of an ORV within City. The complete ORV Ordinance is available at Manistique Public Safety or City Hall.

ORVs must be operated at a speed not to exceed 10 MPH.

ORVs may only operate between the hours of 6:00 am and 11:00 pm.

All operators and passengers must wear a helmet and protective eyewear.

ORVs must be operated on the extreme right-hand side of the roadway with the flow of traffic.

ORVs must come to a complete stop at right angles and before crossing any sidewalk, street or intersection.

ORVs must travel single file unless overtaking or passing another ORV.

ORVs must be operated in a way that is not careless or reckless, or in a way that endangers any person or property.

ORVs must have a lighted headlight and taillight at all times.

ORVs must use proper hand signals when making turns if not equipped with a mechanical turn signal.

ORVs must comply with noise emission standards as defined by law

ORVs must be equipped with a spark arrester type United States Forest Service approved muffler in good working order.

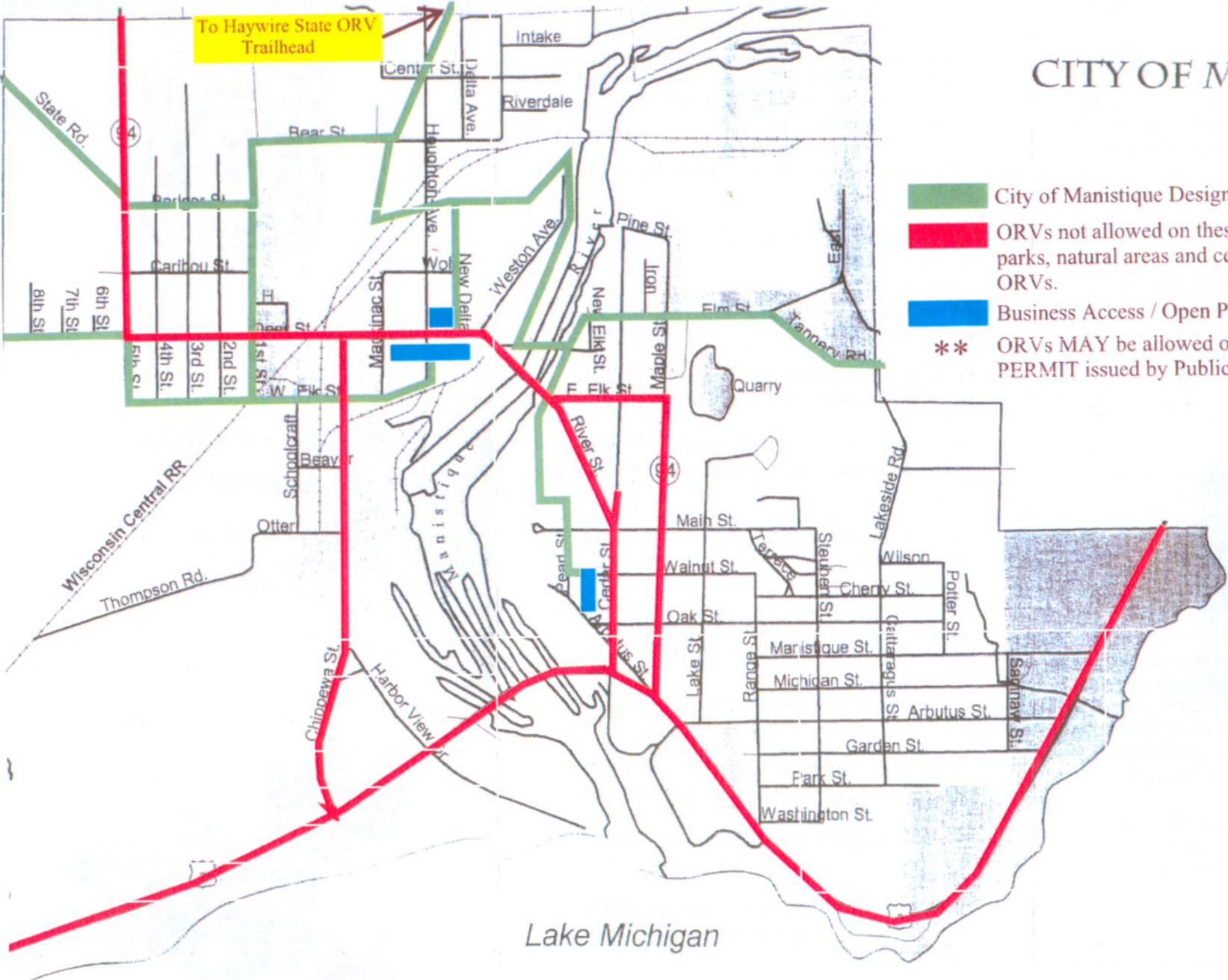

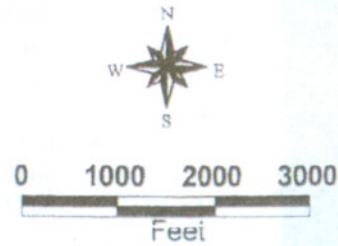
Use of ORVs Within the Manistique City Limits
